**Entry Fee: \$15.00/head. Entries will be taken at weigh-in. Cash, Check, or Money Orders are accepted.**

All Non-Clinton County 4-H / FFA Exhibitors must pay general admission or purchase a season pass.

All sheep and goats must comply to Scrapie rules and have an official Scrapie Tag before being unloaded on the fairgrounds.

All animals must be healthy. No visible signs of abscesses or other contagious diseases will be allowed. Any unhealthy or questionable animals checked by the veterinarian will be at the owner's expense. The Clinton County Senior Fairboard reserves the right to excuse any animal of questionable health.

All out of state animals must have health papers. Health papers can be requested on demand by the Clinton County Senior Fairboard or the fair veterinarian. All other in-state animals are required to follow the Ohio Department of Agriculture rules on health papers.

The sheep and goat classes will be divided by weight (regardless of breed). The classes will be divided by the number of entries by the Clinton County Senior Fairboard and show volunteers.

Be prepared to show out of trailers. If pens are made available, exhibitors are responsible for their own bedding and MUST clean pen before 10:00pm the day of show. Exhibitors who do not clean pens will be charged a \$50.00 cleaning fee per pen to be paid by the exhibitor.

If the exhibitor is a Clinton County 4-H or FFA member showing in the 2018 Clinton County Fair Jr. Fair Market Goat and Market Lamb shows, please contact the Clinton County 4-H Sheep and Goat Committee for approval to use assigned pens.

**MARKET GOATS:** Does are eligible to show as a market animal. Does must be clipped as a market goat.

**MARKET LAMBS:** Ewes are eligible to show as a market animal. Lambs must be slick shorn, no butt wool.

**Senior Fairboard decisions are final. Violations of the rules will result in immediate forfeiture of premiums and awards as well as barred from future competitions.**

### **Competition Information:**

Entries in this class will be open to all guys and gals who have an interest in sheep or wool fashion. The object is to present a class of sheep in the most attractive manner. Contestants are not required to reside in Clinton County.

Sheep do not have to be registered, they must be ewes or Junior Fair market project lambs, conditioned, fitted and trained to show at halter. The contestants must be able to enter the ring and lead the animal without assistance. Entrant does not have to own the sheep, but may be sponsored by another exhibitor. All Rules for exhibiting Sheep at the Clinton County Fair pertain.

The entrant will be judged on the mode of dress selected, which must be attractive and lend elegance to the class. The garment must be predominately wool, but does not have to be home sewn. All entrants must furnish their own garments. The sheep may be decorated to coordinate with the contestant's attire.

Contestants must check-in at 12:00pm on Saturday, July 7, 2018 in the Livestock Expo Building. Changes to narrations are required at check-in.

All sheep must comply to Scrapie rules and have an official Scrapie Tag before being unloaded on the fairgrounds.

1. Garment – Construction & Originality – 40 Points.
2. Poise & Appearance – 35 Points.
3. Control & Presentation of Animal – 25 Points.

Classes offered will be ages 3 through adult. Show order will be from oldest to youngest.

The Senior Fairboard reserves the right to divide the above classes as desired. Senior Fairboard decisions are final.
